#### Duncan urges extended time, creative use of stimulus funds

#### An American Recovery and Reinvestment Act: Growth Opportunities for Community Schools

To help break down what funding is available in the stimulus for community schools, the Coalition for Community Schools has created a Stimulus Brief: [American Recovery and Reinvestment Act \(ARRA\)](#). Several factors should be kept in mind while reviewing this information. First, the funding is temporary and cannot be counted on for projects lasting beyond two years. Second, state and local policymakers must use the funding to increase student performance and should spend some time planning and preparing for these new

allocations. Third, some states are in such fiscal budget turmoil that this additional federal funding will be used to make up for, or attempt to bridge, state budget gaps. In states whose budget situation is not so dire, there will be the opportunity to use federal funding for new and innovative programs.

#### What does the first round of Stimulus funding look like?

The bulk of this initial money will avert teacher layoffs and jump start the next generation of education reform. Specifically: \$32.5 billion in State Fiscal Stabilization Fund allocations; \$5 billion in Title I allocations; \$6.1 billion in IDEA allocations; \$70 million in allocations for the Education of Homeless Children and Youth program; and \$40 million in allocations for the Impact Aid program. #### President Obama's Speech at the Hispanic Chamber of Commerce

On March 10th, President Obama spoke at the Hispanic Chamber of Commerce and stated "that economic progress and educational achievement have always gone hand in hand for America....we are collectively responsible for turning around our schools..." He went on to say that Sec. Duncan will use only one "test when deciding what ideas to support - whether or not it works." #### Public School Kids Outpace Private School Peers in Math

A new study by the University of Illinois has found that public-school students outperform their private-school classmates on the National Assessment of Educational Progress exam, thanks to certified math teachers and a modern, reform-oriented math curriculum, Science Daily reports. To account for the difference in test scores, Sarah Lubienski and her co-authors looked at five critical factors: school size, class size, parental involvement, teacher certification, and instructional practices. "There are so many reasons why you would think that the results should be reversed -- that private schools would outscore public schools in standardized math test scores," she said. "This study looks at the underlying reasons why that's not necessarily the case." Of the five factors, school size and parental involvement were "mixed or marginally significant predictors" of student achievement, while smaller class sizes, which are more prevalent in private schools than in public schools, significantly correlate with achievement. Despite this, many private schools aren't accountable to an external body when designing curricula, and thus may not be keeping up with trends. "There's been this assumption that private schools are more effective because they're autonomous and don't have all the bureaucracy that public schools have," Lubienski said. "But one thing this study suggests is that autonomy isn't necessarily a good thing for schools."

This guide to services in the Allston Brighton neighborhood of the City of Boston is the result of a partnership between two coalitions, the Allston Brighton Early Childhood System of Care (a United Way initiative housed at The Home for Little Wanderers) and the Allston Brighton Partnership for Community Health.

The goal of the Allston Brighton Early Childhood System of Care is to systematically link comprehensive community-based services to better support children birth to seven years old and their families. "System of Care" is an approach to service delivery that, through intensive collaboration, will:

- Improve the coordination of services for children in need of social-emotional support
- Facilitate and increase access for families to a wide array of early childhood services
- Enhance the capacity of existing community organizations to provide early childhood services
- Promote school readiness

### StreetSafe Boston Summer Grants

StreetSafe Boston Summer Grants (formerly Summer Safety Funder Collaborative) makes grants to engage high- and proven-risk youth ages 16-24 in neighborhoods impacted by violence. StreetSafe Boston Summer Grants is part of a new Boston Foundation led multi-year public safety strategy aimed at dramatically reducing youth violence in a subset of neighborhoods that are disproportionately and persistently affected by high rates of violent crime. The initiative, StreetSafe Boston, is a collaboration between local and regional funders, the City of Boston, the Boston Police Department, the Boston Public Health Commission, Boston Centers for Youth and Families, the Boston Housing Authority, YMCA of Greater Boston, the Boys and Girls

Clubs of Boston, and the Black Ministerial Alliance.

#### National Resource Center on Youth Development

The purpose of this funding opportunity is to establish by cooperative agreement a National Resource Center on Youth Development (NRCYD). The NRCYD will serve as a member of the Children's Bureau's (CB's) Training and Technical Assistance Network (T/TA Network). The T/TA Network is designed to improve child welfare (CW) systems and to support States and Tribes in achieving sustainable, systemic change that results in greater safety, permanency, and well-being for children, youth, and families. The specific focus of the NRCYD is to develop, support, improve and maintain a range of program strategies and expertise on the services and supports using the four core principles of Youth Development (see: [www.nrcys.ou.edu/yd](http://www.nrcys.ou.edu/yd)) to assist youth in making a smooth transition to adulthood, achieve permanency, establish and strengthen permanent life connections and reduce the likelihood of dependency on the adult social welfare system. This will be accomplished through the provision of T/TA, consultation and collaboration with partner agencies.

#### iMentor Interactive

Through the Office of Juvenile Justice and Delinquency Prevention, iMentor has received funding to provide financial support to organizations that may not otherwise be able to afford iMi's user fees. The purpose of the grant is to help improve graduation rates through mentoring by providing technical assistance to small and medium-sized nonprofit organizations serving high-school students.

Grant recipients will receive up to \$6,000 in funding for iMi user fees (approximately 200 mentor/mentee users) for one (1) year, with the potential for grants to be renewed for up to three (3) years. If a grantee has fewer than 200 users, the excess funds can be used for iMentor consulting services. Grantees must contribute \$1,500 of their own resources.
